## **5. Committee Reports:**

- a. Financial Report by Cliff Checking \$115,497; Savings \$40,584 for a total of \$156,080 in checking and savings account. Davy has filed all liens or is working with owners who have delinquent accounts.
- b. Water: Scott says it will take Jack approx. one month to get all paperwork done with State. Then will get 3<sup>rd</sup> Wellspring installed. Scott and Chris doubled up on cleaning filters will be on Thursdays and Sundays. If your water pressure is down or non-existent, please give it 30 minutes to recover BEFORE you call the Water Committee. It will recover in time. Davy bringing a generator to Scott on June 11<sup>th</sup> to see if it will work for the pump house. Cliff brought up the summer water lines which are still not done or on the agenda. Scott will get with Woody to get a date and an estimate of the project and Bruce will talk with the 4 owners that are affected. Must get done in 2022 no exceptions.
- c. Lake Joe said fishing has been good. There are several big fish in the catch basin that need to be re-located back into the lake.
